The purpose of our Club is to promote the health and general welfare of its members and to own and operate a swimming pool and other recreational facilities for the exclusive use of the owners and their families.

## History

The Club was originally planned in the early 1960's for the exclusive use of the Country Club Estates housing development, and an ownership share of \$350 was agreed to by 125 of their residents. However, when it came time to collect the funds, several people had changed their minds and membership was opened to any resident in Hillsborough so that the necessary funds could be raised. Still, not enough money was raised, so 37 families offered their homes as collateral to the bank. The Chameski family, from whom the land was purchased, was given several years of free membership until the club could pay them back in full....

At the end of 5 years, the loan from Somerset Trust could not be paid and had to be refinanced for a longer period of time. To underscore the value of \$350 in 1962, the First National Bank of Central Jersey offered loans for people to buy their ownership shares.

The next problem to be solved was the actual building of the Club. One must remember that in 1962 the condominium developments had not started in Hillsborough. New Amwell Road was a small two-lane country road and some neighbors objected to the building of a swim club, fearing noise and excessive traffic....

The Township ordered Roycefield to build a tall fence to screen adjoining property on the east; the loud speaker system was only allowed to be used during swim meets, and no alcoholic beverages were allowed on pool property....

Despite many problems, Roycefield Swim Club opened on July 14, 1962. Opening day and closing day picnics were held at the Manager's home and then, for many years, at the Rizzolo home....

An organization called "Women of Roycefield" formed and met once a month to discuss ways to earn money for the Club. Baked goods were sold at swim meets; women went to the Gallop Poll to answer questions solely for the purpose of raising money for the Club. In general, members used their talents and skills to help the Club get started....

The clubhouse was small with an overhang similar to a porch. There was no office, just restrooms with one toilet and one shower in each....

The swim team was started immediately with Don Bardo as Coach. The team song was sung to the tune of "March from the River Kwai"....

Over the years, a number of improvements have been made. In the late seventies, the overhang on the clubhouse was closed in to give the club more bathroom space, hot water, and an office. In the early eighties, the pool piping was replaced, the cement deck was totally replaced and the basketball court was added....

In 1986 the bathing code in NJ was drastically changed, making Roycefield too shallow to have a diving team, and forcing the pool to reduce the height of the board to the current  $\frac{1}{2}$  meter board we now have....

In 1987 the shed was added to give the Club much needed storage for lawnmowers and other equipment. For the 1989 season, the "back" picnic area was added to allow more space for picnickers. In 1990 a structure, now called the pump house, was erected around the filters and the well pressure tank to protect this equipment from the weather. Permanent grills were added in 1991 in the back picnic area, and in the same year the swim team donated the wooden jungle gym for the playground...

The swim team made improvements to the Club to honor its members when the trophy case was installed in 1990 and the record board was installed in 1992. Additionally, the swim team adopted the name "Rapids" in 1991....

In 2002, a five-year planning committee developed a plan for major capital improvements to the pool and grounds. These renovations, initiated in 2003, included an upgrade to the bathhouse facility, creation of a new playground area, and replacement of perimeter fencing. In 2005, the main pool was expanded to 8 lanes and the kiddy pool was replaced. Additionally, 2 new gas grills were purchased to replace the charcoal grills.

Today, Roycefield Swim Club continues as a thriving swim club in the heart of Hillsborough and maintains its tradition of providing fun, safe, family summer recreation.

## **BOARD OF TRUSTEES**

The Club is managed by an elected Board of Trustees. The Board is elected from among the active ownership. An elected board member serves a term of three years or until the owner is no longer active. New Board Members are elected at the January open ownership Board Meeting. Normally, 1/3 of the board members are replaced yearly.

### **If you are interested in becoming a Trustee:**

- Let your interest be known to the board before September 1st in the year preceding the election.
- The board nominates an election committee in September and will put your name on the list of candidates.
- The Committee is charged with evaluating the candidates and making a recommendation to the board and the ownership.
- All candidates are put up for a vote at the annual Owners' meeting in January.
- If not enough members are up for election at the January meeting, owners at the meeting may be added to the ballot list.

It is strongly recommended that individuals seeking election to the Board attend meetings, and become a part of the board sub-committees. Through these sub-committees, you will be known to the board and the ownership, and be more aware of the board's roles and responsibilities.

### **Officers of the Club:**

- President
- Vice President Administration
- Vice President Pool and Grounds
- Secretary
- Treasurer
- Assistant Secretary and/or Assistant Treasurer, if deemed necessary by the Board of Trustees.

The President, Vice President of Administration, Vice President of Pool & Grounds, Secretary and Treasurer shall be elected annually by the Board of Trustees from among its owners, and shall hold office until the end of the first meeting of the Board of Trustees following the Annual Meeting of the Club. The Assistant Secretary and/or Assistant Treasurer shall be appointed by the Board of Trustees and shall hold office at its pleasure.

### **The Board's other Member at Large Trustee Positions are:**

- Membership Chairperson
- Swim Team Liaison
- Social Committee Chairperson
- Web Site Coordinator
- Legal & Parliamentarian
- Pool and Ground committee
- Special (5-year planning, etc.)

The Board meets once a month, on the second Tuesday of each month at 7:30 pm., usually at the Hillsborough Municipal Building. Refer to the Roycefield website for specific dates, times and meeting locations. Board Members receive a reduced Annual Maintenance Fee and credit toward the Work Service Fee for meeting participation guidelines.

## **OWNERSHIP RESPONSIBILITIES**

### **Ownership Share (Applies to Families only)**

Because of the ownership structure of RSC, **you and the other owners directly share in the ownership of the Club.** By virtue of paying the initial ownership share, this investment grants you all of the ascribed privileges that RSC offers. We are not simply a not-for-profit entity, but rather, each and every owner shares in the present and future operations of the Club.

The Ownership Share is an amount of money retained by RSC as long as you are an owner in good standing. When you resign, the principle is refunded to you after the replacement family has purchased your ownership. In practice, the fee is being refunded quickly because the current long applicant waiting list provides a continuous stream of new owners.

- Family: Only Families may be owners of the Club.
- Owners are assessed Annual Maintenance Fees annually, based on the projected operating expenses to run the Club in the coming season.
- Annual Maintenance Fees are due by April 20<sup>th</sup> of each year.
- Owners are assessed a Supplemental Work Service Fee as set by the Board. This fee may be exchanged for volunteering time during the operating season.
- Only Owners can vote, hold Board positions, and request changes in policy.

Please refer to the website for required fee amounts.

## **Non-Owner "Members"**

At the discretion of the Board, non-family applicants may be admitted to the Club. These annual memberships are: singles and couples; this type of membership is limited to a total of 20. These memberships and associated fees are subject to NJ Sales Tax.

Membership fees are set annually by the Board at its budget meeting.

## **Supplemental Work Service Fee**

All owners and members are assessed a work service fee. The work service fee was created so those people who wanted lower fees could do some work at the Club and receive a rebate. This work service fee is subject to a full rebate if an owner/member performs defined types of Club related work activities. Work Service Fees are credited to your account in the following year or rebated via check **after** the close of the season (generally October). Those people who choose not to perform such work activities do not receive any rebate. This money is used to hire people for maintenance work that is not performed by owners or members.

The most common types of work that qualify for the rebate are preparing the pool grounds for opening and closing the season, and participating with social activities throughout the summer such as dinner & movie nights, and teen & pre-teen parties. Refer to the Social section of this manual for details on various social activity work bond opportunities. Specific work service fee hour allotment for each social activity can be found on the RSC website. Keep your eyes open for e-mails from the Pool & Grounds Committee for work service fee opportunities for Pool Opening and Closing.

Each and every adult has the opportunity to help keep the Club a great place and continue to make it better. While not every owner is expected to serve in an executive capacity (such as on the Board of Trustees), we would like you to think about Roycefield as sort of a home away from home. Just as you have a stake in your own personal property, treating your ownership as an invaluable extension of that property will allow our Club to thrive and prosper in the coming years.

Our Club slogan "Built for Pleasure, not for Profit" testifies to the voluntary and inclusive nature of our association: a place to relax and have fun - a place where your ownership really makes a difference.

## **Updating Personal Information**

## POOL HOURS & DATES OF OPERATION

The season normally runs from the Saturday before Memorial Day until Labor Day. Any changes in this schedule will be noted on the RSC website under "Announcements". The operating hours fall into two categories:

- Preseason: From opening day until last day of Hillsborough School
- Regular Season: from the end of preseason until Labor Day

### Special Closings

(Please note: All special events and early closings will be indicated on the Roycefield web calendar.)

Occasionally, the pool closes for a block of time to accommodate special events (Pre-Teen night, Teen night, Sprint Meet, etc.).

The Club's Swim Team - The **Roycefield RAPIDS** participates in the NJSDC and hosts swim meets. Evening meets are held on Wednesdays throughout July, and the pool will generally close by 5:30 on days when meets are scheduled. All members are welcome to come and watch the Rapids and cheer them to victory.

# CLUB RULES & REGULATIONS

## General Rules

- ALL MEMBERS ARE REQUIRED TO SIGN-IN and PAY FOR ALL GUESTS AT THE TABLE JUST INSIDE THE MAIN GATE UPON ARRIVAL TO THE POOL EACH DAY
- All members and guests shall abide by the pool rules and cooperate with the Club personnel in maintaining proper order.
- Violation of the rules may result in suspension of the pool privileges for such a time as determined by the Board of Trustees
- In cases of suspension, no refund of any dues will be made.
- The Pool Manager on duty has the discretion to close the pool.

## Parking

- Bicycles must be parked in the bike rack.
- Cars must be parked in the parking lot. Please do not park in the loop. The loop is for pick-up, drop-off and deliveries only.
- Handicapped parking is available as indicated by the handicap signs.
- Please drive slowly - 10 MPH Max! **Watch for children at ALL TIMES!**

## Pool Rules

- Any persons showing evidence of skin disease, sore or inflamed eyes, cold, nasal, or ear discharges or any communicable disease shall be refused admission.
- Persons with excessive sunburn, open blisters, cuts, or bandages shall be refused admission.
- Swimming is permitted only when lifeguards are on duty.
- Bathing will not be permitted during an electrical storm. If closed, the pool will open 30 minutes following the last observation of thunder or lightning.
- Children are not to be left within the fenced-in kiddy pool area without adult supervision; an adult must remain in the fenced in area at all times as no lifeguards are on duty in that area.
- Children must be 48 inches tall to go on the slide. Additionally, only one person allowed on the slide at a time. Children **CANNOT** wear flotation devices of any kind on the slide.
- No horseplay at any time. This includes rough water games, chicken fights, pushing, dunking, towels fights, physical contact of any kind on the Club grounds, etc.
- Diving is allowed in diving well area and designated diving areas of the pool only.
- No running in the pool area at any time.
- Lane near diving well is for lap swimmers only.
- Only Nerf-type balls and items provided by the Club may be used in the pool with Staff approval, and only in the deeper end with consideration for all.
- Do not hang on lane lines. Do not sit or climb on the handrails, fence, or ladders.
- A foot bath is provided at the rear of the bath house by the pool stairs. All soiled feet must be rinsed prior to entering the pool.
- No gum chewing allowed in pool; please wrap gum and dispose in trash cans.
- All accidents of any kind must be reported to the pool staff immediately.

- Rescue equipment is for use only in emergencies.
- All first aid must be administered or supervised by the pool staff.
- Disruptive behavior and/or foul language are not allowed.
- Children not toilet trained must swim in the kiddy pool, not in the main pool. NO EXCEPTIONS! Children in kiddy pool must wear swim diapers.
- No smoking allowed on the grounds; Roycefield is a smoke-free environment.
- Alcohol is permitted for those age 21 and above as long as it is consumed sensibly and respect for others is maintained at all times.
  - Any alcohol must be kept in the picnic area.
  - Persons suspected of being under the influence of drugs or alcohol will not be allowed in the pool and may be asked to leave the premises.
- Glass containers are not allowed outside of coolers at any time; liquids from glass containers must be poured into a plastic or paper cup for consumption. Non-breakable containers are recommended over glass ones.
- Please be considerate when using lounge chairs. Chairs should not be reserved or used to hold bathing towels and bags.
- Members must not open, close, or adjust the large umbrellas in the pool area. Please ask guards for assistance.
- Food is not to be left on picnic tables for future consumption. Before you leave the picnic tables, all items must be disposed of and area must be cleaned up so that others may use it.
- No dogs or other animals shall be allowed on the premises, except Certified Service dogs.
- Keep safe, use good judgment, have fun, and respect the water and others at all times.

## Parent Responsibilities

- Parents must supervise their children at all times on the Club grounds.
- All members are responsible for their children, baby-sitters, and guests, concerning the familiarization with and enforcement of all Club rules.
- Parents desiring to teach their children to swim are requested to do so without disturbing others. If children scream and panic, they will be required to leave the pool. Such instruction should be limited to the shallow end of the pool.
- Please ensure that children do not dig in the volleyball court sand as there is a preventative mesh screen below the surface that will be damaged.

## Children

- All Children under the age of 13 must be accompanied by an adult.
- Children age 13 or the summer before they enter 9th grade must be accompanied by an adult unless they can demonstrate to the Club Staff the ability to swim one full length of the pool.
- Babysitters may be assigned the responsibility for children less than 13 years of age if the babysitter will be at least entering 9th grade in the fall. The guest fee must be paid for the non-member babysitter.

## Personal Flotation Devices (PFD)

- PFD: US Coast Guard Approved jackets or vest (Type 2-5) MAY BE WORN ANY TIME.
- All PFDs except those noted above, may only be used on Float Day and only if the person using the PFD is accompanied by an adult or guardian who enters the water and maintains close supervision of the PFD wearer.
- Persons wearing PFDs other than US Coast Guard approved jackets described above may NOT use the diving board or slide. PFDs of any type are not allowed on the slide.

## Float Day

- Float Day occurs every Wednesday during the REGULAR SEASON
- Any flotation device is allowed in the pool on Float Day; however, the Club reserves the right to limit the number of devices.
- All persons must climb on and off any flotation device while in the water, away from the stairs, ladders, & sides.
- All flotation devices must be kept out of the diving area and away from the slide.
- Any device that is attached to the body for flotation is considered a personal flotation device and members must adhere to the rules concerning them.

## Guest Policy

Owners and Members are encouraged to enjoy the Club and bring guests.

- Guests are defined as: any individual who is NOT an immediate family member (spouse/parent, civil partner, and children). Changes in family members must be reported by the Owner/Member to the Membership Chairperson by April 20<sup>th</sup> of each year.
- Guest Fees are determined by the Board each season. Guest Fees are posted at the Club and on the website, [www.roycefield.org](http://www.roycefield.org).
- All Guests must be accompanied by the Owner/Member at all times. Guests must be signed-in and paid for upon entrance to the Club.
- Any Guest is limited to seven (7) visits per season.
- **Guest Tracking:** All Owner/Members are to report their guests at the gate. Owner/Member shall provide the guest name(s). An alphabetical list of all guests will be maintained, and their dates of visit will be noted. If a Guest exceeds the 7 visits, the Owner/Member will be informed. The Guest will NOT be permitted entrance to the Club.
- Owners are limited to a maximum of seven (7) guests at any single visit. If an Owner desires to have more than seven guests, the Owner must apply for a party. See Party Policy.

The following exceptions apply to the Guest Policy visit limitation of seven (7) times. **Special fees may apply. It is the Owner/Member's responsibility to request this special case in writing to the Membership Chair by April 20<sup>th</sup>.** Contact [membership@roycefield.org](mailto:membership@roycefield.org) for details.

1. A registered parent who brings the children to the Club as their guardian, but does not live at the registered Owner address throughout the year (e.g., separation/divorce).

2. A "guardian" (i.e., au pair, who lives in the household or a permanent babysitter not living in the home) who brings the children to the Club **in lieu of** a parent. This individual is subject to Guest Fees when accompanying a parent. Grandparent or relative permanently living within the Owner's household.
  3. A "Special Family Member" (SFM) is an individual living with an Owner for the summer (i.e. exchange student, visiting relative). This individual will be considered a SFM and can become a part of the Owner's family for the season.
- Board Members do NOT pay guest fees.
  - The Pool Manager has the same guest privileges as a Board Member.
  - Club employees may bring one (1) personal guest at a time to the Club when the employee is not working. Employees do NOT pay a guest fee.



## Swim Lesson Program

### Objective:

To provide swim instruction to all Roycefield Swim Club children who wish to learn and/or improve basic swimming skills. Water safety is also an integral part of the program at all levels.

### Program:

Each season RSC will offer a minimum of three (3) two-week sessions and a maximum of four (4) two-week sessions. One of the sessions will be available in August. In general the sessions begin the first full week after the Hillsborough School District's last day of school. A session will not be run for less than 4 swimmers per skill level.

The swimmers will be placed in lesson groups based on skill level. The RSC program consists of three (3) levels: Beginner, Intermediate, and Advanced. Swimmers will advance through the program by demonstrating competency of all required skills.

### Fee:

Roycefield families are offered swim instructions at a nominal fee. In order to offer this program to our entire membership, the Club limits attendance to one session per swimmer per summer.

### Program Conditions:

We ask that you choose a session that your child will be available for the entire two week session (no planned vacations, camps, school enrichment programs, etc) and that you will make every effort to attend all daily lessons.

How to sign-up:

Check the RSC website for the forms that should be completed and mail along with the fee.



## Swim Team Program - *The Roycefield Rapids*

The Rapids are members of the New Jersey Swimming & Diving Conference. The Conference consists of about 28 teams divided into leagues, based on team strength and the previous season record. Roycefield usually competes in the A or B league.

The team is open to all members ages 5 to 18 who are able to swim at least one length of the pool. Swimmers compete in one of five age groups: 8 & under, 9-10, 11-12, 13-14, and 15-18.

Team practices start on the Tuesday after Memorial Day and are held on Monday, Tuesday, Thursday & Friday. Children are assigned to one of three groups, based on their age. During school, practices are held between 3:15 pm & 7:00pm. When school is finished, the practices are held in the morning between 7:45am & 11am.

The team competes in 8 to 10 dual meets, League Championships, Conference Championships, and the Roycefield Sprint Meet. The Dual Meets are held on Wednesday at 6:30pm and Saturdays at 9:15am beginning the last week in June and ending the last week of July. League Championships are held on the last Friday and Saturday in July and the Conference Championships are held the following Tuesday and Wednesday. The Team runs the Roycefield Sprint Meet in which all team members and PARENTS are expected to participate. This one day meet raises several thousand dollars for the team.

The team is supported by the Roycefield Booster Club who assesses a registration fee (per swimmer basis), which covers coaching, a team memento (t-shirt, gym bag with the team name, etc.), entry fees to league championships, the end of the season picnic, and miscellaneous team expenses.

Parents are required to be active either on the Booster Club and/or by working a minimum of 3 dual meets in addition to the Sprint Meet. Volunteers are needed to participate as timers, officials, food sellers, scorers, ribbon writers, 50/50 sellers, or announcer.

All children of the club are encouraged to join the swim team. More detailed information can be found at [www.roycefield.org](http://www.roycefield.org). Registration Forms are available on the web site after April 1<sup>st</sup>.



## PARTY POLICY

Parties at Roycefield are a very popular benefit of pool membership. Any member wishing to bring more than 7 guests in one day is considered to be having a party. For a fee, members are welcome to reserve the back picnic area and one grill for parties.

- ❖ All parties must be scheduled at the pool by the Pool Manager at least 24 hours in advance of the party's starting time.

- ❖ Parties are held during one of two daily party slots:

Pre-Season (Weekends): 1 - 3:30 pm or 4 - 6:30 pm

Pre-Season (Weekdays): 4 - 7 pm

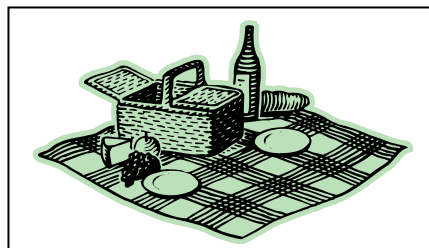
Regular Season: 1 - 4:30 pm or 5 - 8:30 pm All days

A party cannot be scheduled for any time the pool is having a Social Event such as Fourth of July, Labor Day, Teen Night parties or any other time that may interrupt the normal operation of the club.

- ❖ Only one party may occur at the pool at a time, can last up to 3 1/2 hours (2 1/2 hrs. pre-season) and have a maximum of 30 non-RSC guests.
- ❖ Once the party is approved by the Pool Manager, it will appear on the Calendar posted at the club.
- ❖ As a courtesy to all owners, hosts are responsible for their guests, and are required to clean up the picnic area upon completion of their party.

## PICNICKING





In order to maintain a clean pool area for everyone, food of any kind is only to be consumed at the picnic tables in the front, back and side picnic areas. NO FOOD including candy and chips is allowed on the concrete pool deck area, in the baby pool area or in the grassy areas adjacent to the pool deck.

Picnic tables cannot be reserved and must be shared. Please treat the picnic areas as your own, being considerate of others, and clean your area when you are done eating.

Children are NOT allowed to stand on top of the picnic tables as they are used for eating! Drinks are allowed on the grassy area.

**Glass containers are not allowed outside of coolers at anytime as their use is discouraged!** .

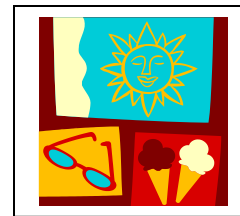
Beverages in a glass container must be consumed from a plastic or paper cup. Whenever possible, please bring plastic bottles to the pool ~ broken glass is a hazard to everyone!

## PROPANE GRILLS



Owners are welcome to utilize the propane grills in the back picnic area for grilling. Grilling utensils are available from the office and propane is provided. Please treat the grills as your own. When you are finished using the grill, you must clean off all cooking surfaces, wipe down the grates, turn off the gas, and clean and return utensils to the office. Grills must be shared, and cannot be reserved unless for use at a scheduled party.

If a propane tank runs out during your use, you must inform the Pool Manager on duty so it can be properly replaced and refilled. If you require assistance with using a grill, please see the Pool Manager on duty.



## **SUMMER SOCIAL ACTIVITIES**
